Subject: Constitution of Dam Design Review Panel for Technically sound and timely execution of Polavaram Project

With the approval of Secretary, WR, RD & GR; it has been decided to constitute a Dam Design Review Panel for technically sound and timely execution of Polavaram Project. The panel would consist of the following members:

6. Chief Engineer, HSO, CWC, Member
7. Chief Engineer, CDO, Government of Andhra Pradesh, Member
8. Member Secretary, PPA- Member Secretary

With the approval of Chief Executive Officer, PPA, the panel can co-opt any other expert member needed.

2. The Terms of Reference of the Panel are as follows:

- i. Provide technical and strategically guidance for design and implementation plan to Polavaram Project Authority (PPA)/ executing agency responsible for design, planning and execution of project
 - ii. Suggest technically appropriate chronological sequence for various activities (Scheduling / Sequencing) in execution of the project to achieve desirable quality in construction and performance of the project
 - iii. Inspect the execution/ implementation of different components of the project and related works whenever required and suggest measures for timely completion execution of the project in technically appropriate chronological sequence for various activities without compromising desirable quality in construction and performance of the project
 - iv. Suggest any other suitable measure for timely and economically completion of the project with paramount quality.
- 3 T/DA to the members of the panel shall be regulated as follows:
- i. Official members shall be treated as on tour
 - ii. Boarding & Lodging and local travel within the project area / Hyderabad to all members shall be arranged by PPA
 - iii. T/DA to non official members of the team mentioned at Sr No (i) to (iii) at Para 1 above, shall be regulated at the same rate as applicable to Central Government official drawing Grade pay of Rs 6600 per month as per Ministry of Finance, Department of Expenditure OM No 19030/3/2008- E-IV dated 23.09.2008 and will be borne by PPA
 - iv. The non official members will be paid per diem of Rs 2500 during the period of visit to project site
4. Member Secretary will coordinate and will organise the meetings/ site visits as per the requirements in consultation with the Chief Executive Officer, PPA and Chairman of the Panel.
