II. Terms of Reference of the Committee:

The objective of the Committee is to overview the implementation of Polavaram Project till completion including the following:


- a) Year wise scheduled programme / construction programme till completion.
- b) Regular Monitoring of the project as frequently as required and at least once in every quarter.
- c) Cost aspects and fund management.
- d) Coordination with Dam Design Review Panel (DDRP) / Contractor / State / Polavaram Project Authority (PPA) / CWC Design Units / CWPRS in respect of various issues related to design, implementation, studies etc. and addressing the bottlenecks.

- e) Examine whether the work on the dam, etc., is proceeding in accordance with the overall plan of execution and as per the approved design of CWC or there are any deviations and take appropriate action and carry out an in-depth examination of the work done so far to ensure that it is commensurate with the Central funds released.
- f) Examine the quality and safety aspects of various components of the project and lay down procedures for the same.
- g) Assessment of construction schedule of the project, vis-à-vis capacity of the construction agencies to complete the project in the scheduled time, gaps in this regard and the plans to fill the same.
- h) Any other issue that is required to be addressed for timely completion of the project.

III. The terms of TA/DA and sitting fee, etc. for the Non-official Members as Special Invitees of the committee will be issued separately.

IV. The Convener will coordinate and organise meetings/site visits and may co-opt any other official/non-official(s) member as needed in consultation with Chairman, CWC.
